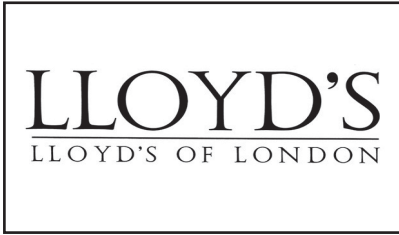

Commercial Ownership Structure



The Abu Dhabi Global Market (ADGM) is an International Highly Regulated Financial Free Zone Centre where the English Common Law is applied. It is located in the Emirates of Abu Dhabi which is the capital of the United Arab Emirates (UAE).

The ADGM is governed by three independent authorities – the Registration Authority (RA), the Financial Services Regulatory Authority (FSRA) and ADGM Courts – making it one of the most trusted financial centers in the region. Its principles are familiar to the business world. Operating under English Common Law also offers a level of certainty to proceedings and it is backed by English courts.

The corporate ownership structure in a Real Estate Asset concept is very common to the commercial Real Estate. Aspectus has created a digital platform that facilitates a commercial-ownership structure, for residential real estate investments. The investment vehicle Aspectus uses for their investment properties is SPV holding companies, established and registered in the ADGM.

Each registered SPV has 1,000 shares in full and is sold to a maximum number of 20 Individual Investors (shareholders). Each investor can own from 5% interest (ownership) in a SPV holding company(ies) up to 100%. A fully approved business plan exists for each SPV and the very same SPV owns a single property unit as per the property title deed.

Each 5% minimum interest (ownership) is equivalent to 50 shares. Aspectus Investor is registered into the ADGM as the official shareholder of the SPV holding company(ies) and obtains an official shares certificate attested from the ADGM.

Escrow Service

For the comfort, protection and peace of mind of all Aspectus Investor's, all funds invested on the Aspectus platform are paid directly into a secure Escrow account managed and controlled by an independent, top-rated, third party International Law Firm.

Funds are distributed to various parties as per the contractual obligations, to ensure that all Investor protections are in place. The independent escrow managers will provide proof of payments to each investor for: Developer payment; Dubai Land Department Land Registry Fees and the Capital Protection Plan underwriting policy.

Loyalty Balloon payments and all Quarterly Net>Returns are paid from Escrow as well as all Capital Protection funds from Year 6 to 12.

There is a one-off Escrow transaction fee charged by the Escrow company of 1% of the total investment, which is added to the final balance of the property portfolio and is clearly shown on the "portfolio check-out" page.
